TERMS AND CONDITIONS OF PARTICIPATION

Terre Haute Torpedoes (A not-for-profit Corporation)

1. **Refund Policy:** Swimmers are allowed a four (4) practice trial period. These are the first 4 scheduled practices for their group. A full refund will be given if the staff is notified prior to the end of the swimmers 4th practice.
2. When a swimmer is moved from one group to another, he/she must pay the monthly fee for the highest group in which they participate. If the swimmer is moved during the middle of the month the fees will be prorated.
3. MONTHLY DUES ARE TO BE PAID BY THE **1ST** DAY OF THE MONTH. DUES WILL BE CONSIDERED DELINQUENT AFTER THE **15TH** DAY OF THE MONTH. DELINQUENT DUES WILL NECESSITATE NON-PARTICIPATION FOR THE SWIMMER(S) UNTIL PAYMENT IS MADE. SWIMMERS STARTING THE SEASON LATE MUST PAY FOR THE **ENTIRE** MONTH IN WHICH THEY BEGIN.
4. Meet entry fees are in addition to the monthly dues. They are due at the time of entry. Non-payment of entry fees will also necessitate non-participation for the swimmer(s) until payment is made.
5. Should a swimmer decide to discontinue participation in the program with the Terre Haute Torpedoes, the monthly dues for the month of which he/she swims **any portion** thereof and any outstanding entry fees are considered an obligation to the Terre Haute Torpedoes, and are payable upon termination of participation.
6. **All swimmers, who are members of the Terre Haute Torpedoes, are required to participate at their highest level of achievement in championship meets (including relays).**
7. Each family is requested to work a minimum of four (4) sessions at any combination of the meets hosted by the Terre Haute Torpedoes. See new volunteer reward schedule for incentives.
