Facility: Eight-lane course, 25 yard, turbulence control lane markers, Colorado timing system, eight lane digital scoreboard, touch pads, backup buttons and digital watches. Deck area seating and parking are available.

Eligibility: Swimmer(s) must be registered with USA Swimming to be accepted into this meet. Age as of July 22, 2008 shall determine the swimmer's age for this meet.

Coaches **MUST** constantly display their USA Swimming coach credential to gain deck access. The meet referee reserves the right to ask for coach credentials displayed and/or deny deck access if coach does not comply or card is no longer valid/current.

Rules: Current USA Swimming and Indiana Swimming rules will govern this meet. USA Swimming Rules 202.3.2-At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition, and warm-down. The Meet Director or Meet Referee shall assist the athlete in making arrangements for such supervision.

Format: All events will be timed finals. **Enter in YARD times.** Be sure that you age-up your swimmers before doing your entry.

Entry Limits: Swimmers are limited to 4 individual events. If an entry is submitted with an individual in more events than allowed, the swimmer will be entered into the order of events until the rule is satisfied. We reserve the right to limit the number of entries and any event to achieve a reasonable timeline. Refunds will be issued if events are limited. The meet entry chairman will notify all accepted teams of any limited events.

Entry

Dates: Entries will be accepted starting June 13, 2008. Entry deadline will be June 27, 2008 at 5:00 pm. We will extend the deadline if the meet is not full. Clubs will receive acceptance notification by e-mail by July 6, 2008.

E-Mail**Entries**

You will need to create a standard Hytek (CL2file) meet entry file on your computer. Allow your computer to zip the file. Submit the file in an e-mail addressed to: rpennington@insightbb.com Make sure the subject line of your e-mail identifies your club entries. In the text of the e-mail include a contact phone number in case we need to discuss your entries. You will receive a reply via e-mail to confirm that we did receive your entry.

IMPORTANT: Once you receive your acceptance e-mail send the Summary Sheet and executed Release and Hold Harmless Agreement with a check immediately so they will be received by the entry chair at the address listed below on or before July 14, 2008.

Fees: The entry fee for this meet will be \$4.00 per individual event, plus a \$1.50 Indiana Swimming surcharge for each athlete entered in the meet. Each relay will be \$6.00. Make checks payable to Center Grove Aquatic Club. **No refunds will be made.**

Deck**Entries:**

Deck entries will be accepted provided a reasonable timeline can be maintained. Deck entries will only be accepted from coaches no later than 45 minutes prior to the beginning of the meet. There is a \$5.00 charge for each event payable at the time of entry.
