I. Call to order

Jensen will be meeting with representatives for West Vigo High School and West Vigo Middle school to ask if they would like to become involved in the swim club. Traditional they have had very little participation.

Jensen presented information for a USA Swimming Conference titled #Swimbiz: Social, Media, and Sponsorship & Swimming. Workshop will be March 29th – 31st at the Olympic Training Center in Colorado Springs, Colorado.
