## **IV. Board Reports:**

# **Head Coach Report:**

- ACST Aquasprints:
  - 26 swimmers attended, 6 Team records, 24 new top 20 THT times, 9 new divisional cuts
- THT Last Chance Time Trial:
  - 44 swimmers attended, 1 Team record, 13 new top 20 THT times, 1 new state cut, 7 new divisional cuts.5 more swimmers on roster than last month
- Would like to invite Evan Austin to visit and speak with Middle School participants during week of VCSC Middle School County Meet
- Would like to attend an ISI-hosted clinic in April in Fishers, IN. Hotels will be comped by Indiana Swimming.

### V. Old Business:

### **Arctic Blast Post-Meet Survey:**

 Survey responses were reviewed. Pre-seeding the meet was well received and will be implemented for future meets. Hospitality also received high marks. Many comments and suggestions pertained to items outside of THT's control. One that wasn't suggested requiring 1650 entrants to provide their own timer in addition to counter. This will be implemented at the next meet.

# **Long Course Callouts:**

- Monday, March 24 & Wednesday, March 26 @ 6 PM
- Coaches will handle the swimmer evaluations. Board members will handle the "dry side" (pass out forms, manage traffic, assist with registration, etc.)
- THT Long Course season begins Monday, April 7

## **THT Bylaw Proposal:**

- Coach Sam would like to add the Head Coach as a voting member of the Board of Directors
  - Would be expected to adhere to THT's Conflict of Interest Policy
  - Adding the Head Coach as a voting member of the Board of Directors would bring the total number of voting members to 10. To compensate, one of the At-Large positions will be eliminated to bring the number of voting members back to an odd number.
  - If approved, the updated board composition would take effect during the next election. Current board members will finish out the current term until the next term begins in October.
  - Official verbiage will be drafted and distributed to the BOD and membership prior to voting on the proposal at the next BOD meeting.

# VI. New Business:

### VCSC Middle School Update:

- Average of 134 middle school participants each night
- Previously, 27 swam for THT during 2023-24 SC season
- THT needs to promote programing during middle school meets
  - There are 2-3 teams every Tuesday and Wednesday...lots of opportunity for recruitment

## Swim Camp:

• In 2024, program ran in two groups...one geared towards middle schoolers (4:00-4:50) and the other open to anyone (5:00-5:50). Programs were run in May, June, and July.

- Coach Sam would like to rebrand the Swim Camp program into a "Summer League" type of offering. It would potentially be offered up to 4 days a week and managed by a coach that doesn't have duties with the existing practice groups.
- Sam will look into surrounding leagues to coordinate with June/July offerings
- Mike will look into how we might be able to utilize the pool outside of THT's 4-8 time slot

## Swim Lessons:

- Instructor Shirts
  - Raine would like to purchase THT-branded swim shirts for the instructors to wear during lessons. THT has shirts (unbranded) that have been unused for about a year. All agreed it would be best to use the existing shirts until they've reached the end of their lifespan before investing in new THT-branded swim shirts.

#### WSI Incentive

- Raine requested that THT offer an hourly rate of \$15 for instructors who obtain a Water Safety Instructor (WSI) certification. WSI certification provides advanced training that would be beneficial to the lesson program.
- Mike motioned to implement the proposed incentive and the motion passed unanimously.

# Strategic Planning w/ Tony Young

- Sam met with Tony Young at Divisionals and Tony offered to meet with THT leadership to help improve our processes and organization
- Head Coach and Board Members are all expected to attend. The meeting would take
  place after the conclusion of the SC championship season or by the middle of May. Will
  likely be in the 6-8 PM time range.
- Ross will create a form to gather availability from THT attendees and give to Sam to follow-up with Tony.
