- Halloween Splash
 - Mike Williams is creating the t-shirt design
- The Summer Steam sanction application is due on 12/1
- Southwest Divisional Championship
 - Lauritzen suggested to open seating on the northside of the pool deck to spectators as there will be a lot of spectators
 - THT should get a banner made to put in front of these spectators' feet for advertising of THT and also to help block excess splash. Anticipate banner cost to be around \$300.
- Arctic Blast
 - Lauritzen discussed pros and cons of express seating

Fundraising/Sponsorship Report-Dr. Bridget Roberts-Pittman

- Swim-a-Thon
 - o Current totals are \$3,679.00/\$5,000.00
 - Roberts-Pittman will send email reminding membership to turn in/finish gathering donations by 9/13.
 - o Potentially host next Swim-a-Thon in September 2020
 - Unused folders have been turned in to USA Swimming as they charge THT \$1/per envelope
- Roberts-Pittman has been getting "cold calls" from USA Swimming about our Swim-a-Thon since
 they noticed media coverage. The lady from USA Swimming informed Roberts-Pittman about the
 USA Swimming Foundation Lesson Grants.

Coach's Report-THT Performance and Development Coach, Dave Breiding

- Meet Schedule
 - o THT will not be competing at the Avon meet in October
 - o Encourages the meet in Plainfield as it is where high school sectionals will be
 - o 11/22-24: RAC Turkey Classic is suggested for Bronze level and up
 - THT will not be attending the Sugar Creek Penguin Plunge as it occurs during Christmas Break for Vigo County schools
 - 2/7-9: THT Arctic Blast and high school girls' Sectionals weekend. THT female athletes can swim 100s vs. 200s; this could potentially draw other athletes
 - 3/1: Indian Creek Aquatic Center End of Season Beach Party Finale occurs same time as the Pike Invitational. Typically boys' high school State Championships/Divisionals are the following week
 - 3/6-8: Southwest Divisional Championship will be hosted by THT. There are 6 (six) other meets this weekend in the state.
- Vigo County School Superintendent Robert Haworth is an avid athletics supporter and communicative with Randy Jensen and Dave Breiding
- Missing starting blocks

- Assume that 10 (ten) are gone. They were originally stored at the Vigo County Aquatic Center but moved because of a fire code violation to a Vigo County School Corporation storage facility.
- We are limiting the number of events that athletes compete in at the Halloween Splash. Each athlete can compete in up to 3 (three) individual events and 1 (one) relay per day.
- Making Waves
 - o Chandler is interested in a contract with THT and can be at the pool on 10/2
 - Dolfin has concerns about working with Making Waves
 - Lauritzen to investigate further

IV. OLD BUSINESS

- Safe Sport Representative is still needed
- THT Handbook needs to be revised for September issue. Revision needs to be on page three to state work sessions will vary per meet but expect 3-4 work sessions per family
- Making Waves contract is up on September 1, 2019. Roberts-Pittman will discuss other
 opportunities with Pacesetter's and Academy Sports to see if they would be a better fit for
 THT.
- Voted to keep coaching incentives for the THT Budget for 2019-2020
 - Coaches to have a volunteer requirement
 - o Child(ren) of coaches have monthly fees waived
 - o Board member incentives cost THT approximately \$3,000/year

- 2019-2020 Board member elections are under way. Jackson and Elizabeth-Meadors are still trying to get interest.
 - Jackson reached out to Jenny Christensen. Unfortunately board meeting dates do not work with her current schedule.
