



## Scholarship Guidelines

2020-2021 Season

The Terre Haute Torpedoes (THT) seek inclusiveness for all eager athletes regardless of financial background. THT will provide scholarships to families meeting income guidelines, as set forth by the United States Department of Agriculture. These guidelines are also used by school corporations to gauge the need for free or reduced tuition and meals.

*Monthly Fee:* Athletes qualifying for a scholarship will have their monthly fee reduced to **40%** of the athlete’s group level fee.

*Pool Rental Fee:* Athletes qualifying for a THT scholarship are exempt from the VCSC pool rental fee.

*USA Swimming Fee:* Athletes qualifying for a THT scholarship also qualify for a reduced USA Swimming annual membership fee. This fee is the responsibility of the athlete. The 2020-2021 USA Swimming reduced fee is approximately \$5 and the USA Diving fee is \$20.

*Meet Fees:* All meet fees (home, away and THT time trial fees) are not included in the scholarship and are the athlete’s responsibility. For swimmers, THT offers incentives for adult family members who volunteer as officials for home meets and time trials. Officials training is required. See “THT Officiating Incentives” on the THT website.

### ***How does my family apply for a scholarship?***

If the athlete receives free/reduced school fees, “Scholarship Worksheet A” will need to be completed, attaching a copy of the school corporation’s approval letter for free/reduced fees. If the athlete’s family has not completed a US Department of Agriculture application, “Scholarship Worksheet B” should be completed.
